**ORDER DIRECTING CLERK TO FILE UNDER SEAL**


This matter came before the Court for hearing on July 23, 2025, on Defendant's "Amended Motion to File Documents Under Seal," which requests to seal the unredacted versions of "Defendant's Motion for Attorney Fees and Costs," "Defendant's Motion for Sanctions Pursuant to Section 57.105, Florida Statutes," "Defendant's Motion for Summary Judgment (Loss Did Not Occur During Policy Period)," "Defendant's Motion for Summary Judgment (Concealment or Fraud Provision)," "Defendant's Motion for Summary Judgment (Failure to Satisfy Post-Loss Contractual Obligations)," and, "Defendant's Motion for Summary Judgment ("No Damages")" (hereinafter collectively referred to as the "Motions"). The Court having reviewed the agreement of the parties, the request to file the Motions under seal and the Motions, and otherwise being duly advised in the premises, it is ORDERED AND ADJUDGED that:

1. The motion is **GRANTED**.
2. This is a non-criminal case for alleged breach of contract regarding a first party property insurance matter.
3. The matter is confidential based upon Florida Rules of Judicial Administration 2.420(c)(9)(A)(iv). The contents of a global settlement agreement between the parties is confidential, and, the parties agreed it would remain confidential. The contents of the global settlement agreement must remain confidential to obtain evidence to determine legal issues in this case.
4. The Court finds that the Motions have already been filed with the Clerk with the confidential information redacted, and, it is in the best interest of the parties that

the unredacted Motions be sealed in the Court file. The non-confidential portions of the Motions are already available to the public. No less restrictive measures are available to protect the interests described herein.

5. No parties' name is determined to be confidential.
6. The six (6) Motions identified herein are deemed to be confidential:
  - a. "Defendant's Motion for Attorney Fees and Costs;"
  - b. "Defendant's Motion for Sanctions Pursuant to Section 57.105, Florida Statutes;"
  - c. "Defendant's Motion for Summary Judgment (Loss Did Not Occur During Policy Period);"
  - d. "Defendant's Motion for Summary Judgment (Concealment or Fraud Provision);"
  - e. "Defendant's Motion for Summary Judgment (Failure to Satisfy Post-Loss Contractual Obligations);"
  - f. "Defendant's Motion for Summary Judgment ("No Damages)"
7. The Defendant shall file the unredacted Motions containing the confidential information with the Clerk of Court, indicating that such Motions are confidential.
8. Only the parties and their designated counsel of record are permitted to view the confidential information.
9. The Court finds that the degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth herein.
10. The Clerk of Court is directed to publish this Order in accordance with subdivisions 2.420(e)(4).
