**AGREED ORDER ON MOTION TO DETERMINE CONFIDENTIALITY OF
COURT RECORDS AND TO SEAL RECORDS**

THIS CAUSE came before the Court upon the Respondent's Motion to Determine Confidentiality of Court Records and to Seal Records, filed May 13, 2025, and the Court, having considered said Motion and the Court file, the Court does hereby FIND, as follows:

1. The Court has jurisdiction over the subject matter set forth in the parties' Motion.
2. The underlying case in this matter is a domestic relations proceedings related to a dissolution of marriage with minor children.
3. The parties have agreed to the relief requested in the Respondent's Motion.
4. The court filings at issues in this case are private and confidential matters pursuant to established public policy set forth in the Florida or United States Constitution or statutes or Florida rules or case law." Fla. R. Gen. P. & Jud. Admin. 2.420(c)(9)(A)(vii).
5. The following documents shall be deemed confidential and sealed to the public:
 - A. Petitioner's Financial Affidavit (filed December 18, 2024)
 - B. Respondent's Financial Affidavit (filed December 30, 2024)
 - C. Petitioner's Affidavit of Income (filed March 27, 2025)

D. Notice of Filing Child Support Guidelines Worksheet (filed April 21, 2025).

6. The Court, the parties and the parties' counsel shall be the only individuals entitled to view the confidential information contained in the above-identified records.

7. The Court finds that the degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth herein.

8. No less restrictive measures are available to protect the interests of the parties and there is no other level of protection that will accomplish the purpose set forth herein.

It is therefore, **ORDERED, ADJUDGED, and DECREED:**

A. The Motion to Determine Confidentiality of Court Records and to Seal Records, filed May 13, 2025, is hereby GRANTED.

B. The following documents shall be deemed confidential and shall be sealed by the Clerk of the Court and such confidential classification shall apply retroactively to these filings.

- i. Petitioner's Financial Affidavit (filed December 18, 2024)
- ii. Respondent's Financial Affidavit (filed December 30, 2024)
- iii. Petitioner's Affidavit of Income (filed March 27, 2025)
- iv. Notice of Filing Child Support Guidelines Worksheet (filed April 21, 2025).

C. The court documents sealed by this Order shall only be accessible to the Court, the parties, and the parties' counsel.


D. The Court reserves jurisdiction to enter such further orders as it deems necessary, including, but not limited to, the enforcement of this Order.
