ORDER GRANTING MOTION TO DETERMINE CONFIDENTIALITY OF COURT RECORDS AND TO CONDITIONALLY SEAL FINANCIAL DOCUMENTS

THIS CAUSE having come before the Court on the Joint Motion to Determine

Confidentiality of the Court Records and to Conditionally Seal Financial Documents filed on

August 7, 2025 and the Court having reviewed said motion, file, and otherwise being fully

advised in the premises:

The Court **FINDS** as follows

- 1. The Court conducted an in-camera review of the Financial Affidavits, Marital Settlement Agreement, Parenting Plan, and Child Support Guidelines Worksheet of the parties.
- 2. Both parties are employed in sensitive federal law enforcement positions— Petitioner with DHS/ICE and Respondent as a special agent with the FBI.
- 3. Public disclosure of their financial information and related documents presents a substantial likelihood of misuse by third parties, posing a risk to national security and personal safety.
- 4. The privacy interests and potential dangers to the parties and their children outweigh the presumption of public access to court records.
- 5. The Court finds conditional sealing is appropriate under Fla. Fam. L. R. P. 12.400(c) and Fla. R. Jud. Admin. 2.420.

- 6. The sealing is conditional: any party or third person may petition for access, showing need for government or judicial accountability or protecting First Amendment rights.
 - 7. Notice has been provided in compliance with Fla. R. Jud. Admin. 2.420(d).
- 8. Any motion to reopen the sealed documents will be handled under Fla. Fam. L. R. P. 12.400(c)(3) and will include notice and a hearing.

It is therefore ORDERED and ADJUDGED:

- A. The Motion to Determine Confidentiality of Court Records and to Conditionally Seal Financial Documents is hereby **GRANTED**.
- B. The Clerk shall seal all Financial Affidavits, Marital Settlement Agreement,
 Parenting Plan and Child Support Guideline Worksheets, so as the public cannot view same.
