ORDER DETERMINING HOMESTEAD STATUS OF REAL PROPERTY

On the petition of _____ for an order determining homestead status of real property (the "property"), all interested persons having been served proper notice of the petition and hearing, or having waived notice thereof, the court finds that:

1. The decedent died testate / intestate (*circle one*), on _____ (*insert date of death*), was domiciled in ORANGE County, Florida and was (*check all that are appropriate*):

- a. ☐ Not survived by a spouse or the spouse waived their homestead rights.
