**ORDER GRANTING DEFENDANT CIGNA HEALTH AND
LIFE INSURANCE COMPANY'S UNOPPOSED MOTION
TO DETERMINE CONFIDENTIALITY OF COURT RECORDS¹**

THIS CAUSE having come before the Court upon Defendant Cigna Health and Life Insurance Company's ("Cigna") Motion to Determine Confidentiality of Court Records (the "Confidentiality Motion"). The Court has reviewed the Motion and is otherwise fully advised in the premises. Accordingly, it is:

ORDERED AND ADJUDGED that:

1. The Confidentiality Motion is **GRANTED**.

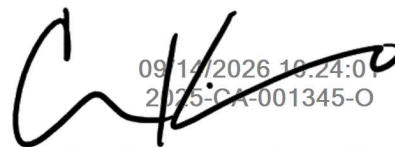
2. Cigna is permitted to file the confidential information identified in the Confidentiality Motion as the “Confidential Motion Information” under seal and such information shall be treated as confidential by the Clerk of Court absent further order from this Court.

3. The named parties to this action, counsel of record for the named parties, the Court, the Clerk of Court, and experts are permitted to view the confidential information in a manner consistent with the parties’ Confidentiality Agreement.

4. The Court finds that the degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in Fla. R. Jud. Admin. 2.420(e) and finds that no less restrictive measures are available to protect those interests.

5. The Clerk is directed to publish this order in accordance with Fla. R. Jud. Admin. 2.420(e)(5).
